

Background

Fitness check conclusions : Within the framework of broader biodiversity policy the Nature Directives are fit for purpose but fully achieving their objectives and realising their full potential will depend on substantial improvement in their implementation in relation to both effectiveness and efficiency, working in partnership with different stakeholder communities in the Member States and across the EU, to deliver practical results on the ground.

Fitness check of the EU nature directives - findings

- Funding shortage and weak policy integration
- Cases of inflexible application & permitting delays by national & local authorities
- Insufficient knowledge, awareness, engagement & cooperation

Structure and objectives

- The Action Plan aims to rapidly improve practical implementation of the Nature Directives and accelerate progress towards the EU 2020 goal of halting and reversing the loss of biodiversity and ecosystem services
- It covers 4 priority areas and includes 15 concrete actions (with 114 sub-actions) addressing key findings of the Fitness Check
- Timeframe is 2017-2019



Priorities of the Action Plan

- Priority A: Improve guidance & knowledge and ensure better coherence with broader socioeconomic objectives
- Priority B: Building political ownership and strengthening compliance
- Priority C: Strengthening investment in Natura 2000 and improving synergies with EU funding instruments
- Priority D: Better communication and outreach, engaging citizens, stakeholders and communities
