


We digitize the rules for the use of nature

We achieve this goal by digitizing all relevant regulations, including laws and local agreements that govern behavior in nature.




Mission

We want to create a global dataset of all protected areas that includes baseline data and rules. We support all digital platforms to use this data through our API.


Protected areas worldwide

The platform


The platform is fully functional and the number of content creators is increasing. Outdooractive is the first platform to use the data.
