


Health and nature Board







High diversity in forest ecosystem types,, but not only forests

Frondoses / Frondosas / Broad-leaved

- Surera (*Quercus suber*)
- Alzina (*Quercus ilex*)
- Roures (*Quercus cadyucifolis*)
- Faig (*Fagus sylvatica*)

Network of healthy paths in Natural Parks

Healthy paths vs forests paths with therapeutic function: PARAMETERS

Parameters	Healthy itineraries (IS)	Therapeutic forest itineraries (IFT)
Distance	Maximum 10 Km	Maximum 3 Km
Difficulty	Medium - low	Low
Elevation	There may be unevenness in very specific sections	There may be unevenness in very specific sections
Maximum slope	50% punctually	- - -
Approximate duration	2-5 hours	2-3 hours
Related services	Nature guides, mindful walks...	Forest baths, mindful walks, forest therapy...
Predominant ecosystem	Various ecosystems / forest / mosaic	Mature forest (at least 70%)
Spaces characteristics	Diversity of spaces, environments and landscapes (forestry, views, meadows...)	Diversity of spaces within the forest ecosystem, shadows, open spaces
Activities	Can be guided or not	Guided or preferably guided




