

The Czech Nature Conservation Journal, is a bi-monthly publication that is aimed at professional and voluntary nature conservationists, as well as the general public interested in natural and landscape heritage conservation and management. It is issued by the Nature Conservation Agency of the Czech Republic. They plan on publishing an English version once a year. In this issue in English, selected articles from the 2019 volume are presented. With special attention on topics relating to biological diversity conservation and management, protected area management and landscape integrity including water regime in relation to climate change. Challenges and opportunities in managing European protected areas during and after COVID-19

Collaboration with Cambridge University

We have a unique opportunity to work with researchers at Cambridge University to [examine the impacts of covid on protected areas management](#). This is a crucial piece of work, and EUROPARC would very much encourage members to **indicate their willingness to participate** by emailing europarc@europarc.org, with the subject title **FIDELIO**. The research team is planning to distribute questionnaires in all areas and possibly conduct personal interviews depending on the language required and the level of support that can be provided by the park authority in translation. Workshops will also be organised during the project with EUROPARC hosting **two online workshops. One 1st July and 1st September** (in English). We will liaise with the Researcher to identify representative parks.
